Henderson AAA Auto Repair Hawaiian Vacation Giveaway Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. SWEEPSTAKES IS ONLY OPEN TO LEGAL RESIDENTS OF NEVADA WHO ARE AT LEAST 21 YEARS OLD.

- 1. <u>Sponsor</u>: The Sweepstakes Sponsor is AAA Northern California, Nevada & Utah, 1277 Treat Blvd, Suite 1000, Walnut Creek, CA 94597 ("AAA" or "AAA NCNU" or Sponsor").

- (2) Complete, in its entirety, the mail-in submission entry form you received in the mail or at the Henderson AAA Auto Repair Center, and mail to: Henderson AAA Auto Repair Center, 1511 West Sunset Rd, Henderson, NV 89014. A mailed-in entry form must be postmarked no later than March 21, 2020.
- (3) Submit an e-mail entry to Membership@GoAAA.com containing the following information: Name of Giveaway: (Henderson AAA Auto Repair Hawaiian Vacation Giveaway) and Contact information: Name, Address, City, State, Zip, E-mail, Phone Number, and AAA Membership ID. An e-mailed entry form must be timestamped no later than 11:59:59 pm MST on March 21, 2020.

Only one Entry per person. No mechanical reproductions permitted. Any duplicate entries will be disqualified. Entries become the property of the Sponsor and will not be returned.

All eligible Entries received during the Promotion Period will have an equal chance of winning. Incomplete Entries will be disqualified. Proof of delivery or receipt of any kind will not be deemed proof of Entry. Any attempted form of entry other than as described herein is void.
